

**50/50 Raffle Official Rules**  
**Sponsored by: Syracuse Football Club, Inc.**

1. All 50/50 Raffle tickets, transactions, participants, purchasers and winners are subject to these Official Rules, and to all applicable statutes, rules and regulations, including, but not limited to, the New York General Municipal Law, the Rules and Regulations adopted pursuant thereto, local laws and all other applicable rules adopted by the New York State Racing and Wagering Board.
2. Raffle tickets for each game will be sold at from the opening of the gates of the Carrier Dome through the end of half-time during the football game. The winning 50/50 Raffle ticket holder shall be entitled to a cash prize equal to fifty percent (50%) of the gross 50/50 Raffle ticket sales at the game. (the "Prize").
3. One winning 50/50 Raffle ticket will be randomly drawn by the Syracuse Football Club, on the football field at the start of the 4<sup>th</sup> quarter of play of the game. The winning 50/50 Raffle ticket number will be announced during the 4<sup>th</sup> quarter of such game over the Arena's public announcement system and will be posted on the Syracuse Football Club's website ([www.syracusefootballclub.com](http://www.syracusefootballclub.com)) for a period of thirty (30) calendar days after such game. You do not have to be present to win.
4. In order to prove entitlement to any Prize, the winning 50/50 Raffle ticket holder for each game must submit all documents required by these Official Rules to the Syracuse Football Club at P.O. Box 15009, Syracuse, NY 13215-0009, within thirty (30) calendar days after such winning raffle is selected. (the "Prize Claim Expiry Date"). Where the Prize Claim Expiry Date occurs on a Saturday, Sunday or legal holiday, the Prize Claim Expiry Date shall be the next business day. Copies of the forms may be downloaded from the Syracuse Football club website ([www.syracusefootballclub.com](http://www.syracusefootballclub.com)).
5. The winning 50/50 Raffle ticket holder must submit the following to the Syracuse Football Club prior to the Prize Claim Expiry Date, in order to receive the Prize:

- a. The original designated winning 50/50 Raffle ticket stub, and
- b. A completed, executed "50/50 Winner Release Form" and a W-9 IRS Form.

All Prizes may be subject to an additional withholding tax, and all winners are responsible for the payment of any taxes as a result of winning the Raffle. Failure to comply with the above will result in forfeiture of the Prize.

6. The winning 50/50 Raffle ticket holder agrees to have his or her name and image published by the Syracuse Football Club solely for publicity and promotional purposes without notice, review or approval and without further payment or consideration
7. The winning 50/50 Raffle ticket holder at each game shall be entitled to a cash prize equal to fifty percent (50%) of the gross 50/50 Raffle ticket sales during such individual game, as determined by the Syracuse Football Club in its sole discretion (the "Prize"). A check in the amount of the Prize, net of any withholding, if applicable, will be mailed to the winning 50/50 Raffle ticket holder within fifteen (15) days after such ticket holder has submitted the completed documents as set forth above.
8. All Prizes not properly submitted or claimed on or prior to the applicable Prize Claim Expiry Date, and all mailed Prize checks which are returned undeliverable, are hereby deemed forfeited, and any or all of the amount of such forfeited Prizes may be retained by the Syracuse Football Club to be used for other charitable purposes and/or added to one (1) or more Prize pools during other games, at the sole discretion of the Syracuse Football Club.
9. The Raffle is only open to persons eighteen (18) years or older. All 50/50 Raffle ticket sales are final.
10. A 50/50 Raffle ticket is void, and the holder thereof is ineligible to receive any Prize relating thereto, if there is reasonable proof, in the sole discretion of the Syracuse Football Club, that such ticket was stolen, not properly issues, ineligible, illegible, altered, counterfeit, or printed in duplicate or in error.
11. The Syracuse Football Club is a not-for-profit corporation existing under the laws of the State of New York and is a distinct legal entity from Syracuse University. The Syracuse Football Club is solely responsible for the sponsorship, operation and conduct of the 50/50 Raffles.
12. By participating in any 50/50 Raffle, each participant and his or her successors, heirs and assigns, releases and forever discharges the Syracuse Football Club and Syracuse University, and their respective affiliates, subsidiaries and members, as well as the employees, directors, officers and agents of any of the forgoing entities, from any and all costs, fines, claims, losses, damages or liabilities of any nature resulting directly or indirectly, from acceptance, receipt, ownership, possession, misuse or use of any Prize or participation in any 50/50 Raffle. Each participant further waives any right to claim ambiguity in the operation of any 50/50 Raffle or in these 50/50 Raffle Official Rules. Each Participant agrees that the Syracuse Football Club and Syracuse University have made no representation, warranty or guaranty, expressed or implied, in law or in fact, relative to the operation of the 50/50 Raffles or to any Prizes, and are not responsible for any errors in 50/50 Raffle operations, Prizes or materials. Each Participant waives all rights to claim punitive, incidental and consequential damages, attorneys' fees or any damages from or against the Syracuse Football Club and/or Syracuse University other than actual out-of-pocket costs incurred to purchased a 50/50 Raffle ticket.
